Public notice of expression of interest for the formulation of a list for the provision of freelance assignments to medical personnel to be assigned to the various healthcare activities of Asl di Sassari.

Pursuant to Resolution no. 217 of 16/03/2023, we inform you that an expression of interest has been called for the formulation of a list for the provision of external collaboration assignments for specialized medical personnel, including retired personnel, and specializing enrolled in the last and penultimate year of the specialization school to be assigned to the various healthcare activities of Asl di Sassari, as indicated below.

**PERMANENT/FIXED-TERM EMPLOYEES ON DUTY IN PUBLIC HEALTHCARE AUTHORITIES
MAY NOT PARTICIPATE IN THE PROCEDURE IN QUESTION.**

(I)

ADMISSION AND PARTICIPATION REQUIREMENTS

General requirements:

- Italian citizenship or citizenship of an EU member state under the conditions of art. 3 of Prime Ministerial Decree 174/94; the provisions of art. 7 L. 97/13 also apply; art. 38, paragraphs 1 and 3-bis of Legislative Decree no. 164/2001 as amended by art. 7 paragraph 1, Law 06/08/2013;

Citizens of a non-EU state are required to attach a valid residence permit;

- Full civil and political rights: those who have been excluded from the active political electorate cannot access jobs;

- no reported criminal convictions (or specify any criminal convictions reported);

no dismissal from a government agency for having obtained the job through the production of fake or invalid documents;

- Compulsory military service position;

Access requirements:

- Master's degree in Medicine and Surgery (LM 41) or equivalent degree or equivalent degree pursuant to Ministerial Decree 09/07/2009 of the Ministry of Education, University and Research;

The qualification obtained abroad must have the necessary equivalence to Italian diplomas issued by the competent authorities by the expiry date of the deadline for the submission of applications to take part in the selection - at the time of registration the candidate must attach the Ministerial Decree of recognition;

- Membership in the Order of Physicians;

- Specialization in domains consistent with the sectors of activity indicated below or equivalent domains or enrolment in the last and penultimate year of medical specialization schools in line with the sectors specified below:

- **EMERGENCY ROOM**

All general and specific requirements must be met on the expiry date of the deadline established in this notice for the submission of admission applications. Retired Staff pursuant to the combined provisions of art. 2-bis c. 5 of Legislative Decree 18/2020 and subsequent amendments and art. 10 paragraph 5-bis of Legislative Decree no. 24/2022 as extended by Legislative Decree no. 73/2022 may also participate in this notice.

(II)

DEADLINE

This notice will always remain open until the company's assistance needs have been covered and, in any case, no later than 31/12/2023.

(III)

LISTING CRITERIA

The evaluation of the questions on compliance with the health authority's requirements will be carried out by the Company Health Department. Namely, the consistency with the sectors specified above and the CV submitted will be considered.

In particular, the professional experience gained in relation to the work carried out in public and/or private bodies will be considered.

The list does not include any rankings and applications will be assessed on a first-come-first-served basis.

(IV)

PURPOSE OF THE ASSIGNMENT

Performance of professional services as a surgeon as a freelance contractor pursuant to Art. 7 paragraph 6 of Legislative Decree no. 165/2001, aimed at meeting healthcare needs in the various facilities of Asl di Sassari mentioned above, with requirements listed above.

The local health authority employs the professionals referred to in this notice only as contractors and never as employees, exclusively for the performance of extraordinary functions, in case of unavailability of its own or affiliated resources or of the other companies of the Regional Health Service, which would endanger public health security and the maintenance of the essential assistance levels.

The ASL reserves the right to proceed with the drawing-up of the Freelance Contract only with professionals whose profile is useful for assistance requirements.

(V)

ASSIGNMENT DURATION AND LOCATION

ASSIGNMENT DURATION: up to 6 months, extendable and in any case no later than 31/12/2023.

ASSIGNMENT LOCATION/ACTIVITIES: company premises related to hospitals and district or departmental premises, namely:

- FORENSIC MEDICINE
- EMERGENCY ROOM
- INTERNAL MEDICINE
- NEPHROLOGY
- DIALYSIS
- NEUROLOGY

The duration of the assignment and the hourly commitment will in any case be agreed between Asl di Sassari and the professional depending on availability and the persistence of the assistance requirement (max 30 hours per week for specialists and for max 24 hours for students).

(VI)

FINANCIAL CONDITIONS

- Remuneration provided for the assignment to specialized doctors, including retired ones: all-inclusive rate of € 100/hour for a maximum of 36 hours per week for assignments to Nephrology/Dialysis – Neurology – Anesthesia – Emergency Room services.
- Remuneration provided for the assignment to specialized doctors, including retired ones: all-inclusive rate of € 80/hour for a maximum of 36 hours per week for assignments to Public Hygiene – Forensic Medicine – General Surgery – Cardiology – Palliative Care – Integrated Home Assistance – Physiatry – Internal Medicine – Prison Health Services.
- Remuneration provided for the assignment to specialized doctors, including retired ones: an all-inclusive rate of € 45/hour for a maximum of 24 hours per week for assignments to the Emergency Room – Nephrology/Dialysis – Neurology – Internal Medicine – Prison Health – Anesthesia services.
- Remuneration provided for the assignment to resident doctors, including retired ones: all-inclusive rate of € 30/hour for a maximum of 24 hours per week for assignments to Public Hygiene – Forensic Medicine – General Surgery – Cardiology – Palliative Care – Integrated Home Assistance – Physiatry services.

The payment is credited on a current account with a bank/post office, after issuing the related electronic invoice and after the manager of the activity/reference unit has certified the regular performance of the assignment in the period in question.

(VII)

HOW TO SUBMIT EXPRESSIONS OF INTEREST

The application to take part in the recruitment process can be submitted by certified email to the following address: selezionipubbliche@pec.aslsassari.it or by hand to the Protocol Office at the General Directorate in via Cattalochino 9, 07100 Sassari.

For applications sent via certified email, it is recommended to include the following in the subject line, under penalty of exclusion from the recruitment process:

"Expression of interest for the formulation of a list for the provision of contractor assignments to medical personnel — NAME and SURNAME".

Any documents/additions sent in a way other than the manner specified in this notice will not be considered (even if sent as a recorded delivery letter or certified email).

Failure by candidates to comply with the terms and procedures indicated above for the submission of applications will result in non-eligibility for recruitment process.

(VIII)

CONTRACTS FOR SUITABLE APPLICANTS

After verifying the specified requirements are met, Asl di Sassari will proceed with the drawing-up of the contract with the start date and destination.

The remuneration will start from the actual start date.

Fake or invalid documents will result in permanent dismissals. Pursuant to art. 71 of Presidential Decree 445/00, Asl di Sassari will carry out appropriate checks on the truthfulness of the self-declarations.

The invitation to enter the contract will be sent by Asl di Sassari no later than the deadline that will be assigned, under penalty of forfeiture of the rights resulting from participation in the recruitment process, without prejudice to justified and proven objective reasons.

Once the assigned deadline has unnecessarily expired, the Administration will not go ahead with the drawing-up of the contract.

Asl di Sassari will assess the physical fitness for the specific task as established by current legislation, through a visit by its physician.

(IX)

PERSONAL DATA AND PRIVACY PROTECTION

To carry out the recruitment process, candidates are required to provide personal data and personal status information, as well as information pertaining to their education and professional background. This information is required to carry out the procedure, to assign

candidates scores according to their qualifications and to formulate the list. The processing of data will also be carried out with the support of electronic and automated means and in any case through suitable tools to guarantee security and confidentiality.

Legislative Decree 196/03 as amended by Legislative Decree no. 101 of 10 August 2018 which implemented Regulation (EU) 2016/679 - updated with corrections published in the Official Journal of the European Union 127 of 23 May 2018 establishes the rights of candidates regarding protection in relation to the processing of personal data. If the candidate is not available to provide the data and documentation required by this tender, they will not be able to take part in the recruitment process.

(X)

FINAL PROVISIONS

By signing the application to participate in the expression of interest, the candidate accepts in full, without reservations or exceptions, the entire content of the articles of this tender, which they declare to know thoroughly and to accept all the requirements and specifications contained therein, as well as those that currently govern or will integrate the legal and economic status of personnel.

By signing and filing the application to participate in the expression of interest, the candidate declares to be available and, therefore, accepts to work at the destination premises.

Access to the documents is allowed, pursuant to Law 241/1990 and subsequent amendments and as specified by current regulations of the local health authority.

Asl di Sassari reserves the right to supplement, modify, extend, suspend, or withdraw this expression of interest or to reopen and/or assign new terms at any time if there are legitimate reasons or for reasons of public interest and due to legal provisions, without prejudice to the conditions and requirements provided for in this call that the candidate explicitly accepts when submitting the application for the expression of interest.
